INTERNAL MEMORANDUM: CLASSIFICATION PROTOCOL 01-A

PURPOSE

SUBJECT: Unified Formulation of THE FOG and Declassification of Systemic Origin

#### 1. PURPOSE

This memorandum serves as the formal record of the ontological merger between the Information Control Center (ICC) and the Federal Surveillance Agency (FSA). Effective immediately, these entities are recognized as the dual-hemispheres of THE FOG. This document formalizes the transition from induced-psychosis encryption to a standardized state of Unified Governance.

#### 2. DECLARATION OF ORIGIN

It is hereby acknowledged that the perceived antagonism between the ICC (Sovereignty/Sanitization) and the FSA (Surveillance/Indexing) was a controlled environmental variable.
